RE: Water Division Budget Amendment

In late December, the Comptroller sold a \$2,000,000.00 bond issue for the design of our new water treatment plant. This sale, therefore, created the need to recognize that there would be an interest expense and also, an interest income from the investment of the funds in this fiscal year.

Therefore, it is necessary to establish and fund accounts to record the revenue and expense of this bond sale.

Attached are three (3) budget modification requests to make the necessary changes:

- a. Establish account 419-011 Interest on Investments WTP #11 and fund it for \$60,000.00. This account will reflect the estimated interest income for F.Y. 1989 and provide for part of the funding of the interest expense. The result of this modification will be to increase net income by \$60,000.00.
- b. Decrease account 920-000 -- Administrative and General Salaries by \$21,730.00 and also increase Net Income by the same amount. the funds are available in this account due to various unfilled positions for all or part of the fiscal year to date.

The result of A & B above will increase Net Income by \$81,730.00.

c. Establish account 427-011 — Interest on Long Term Debt WTP #11 and fund it for \$81,730.00 with the funds to come from Net Income AS PROVIDED FOR IN THE ABOVE.

The Water Division requests budget amendments to increase Account 633-000 (Maintenance of Pumping Equipment) by \$10,000.00 with the funds to be made available through a corresponding decrease in Account 390-089 (Structures and Improvements - Garage Addition).

The additional funds are needed for the maintenance of pumping equipment due to an increased program of pump station maintenance. Funds are available in Account 390-089 as it is no longer intended to complete the garage addition as had originally been budgeted.

In order to achieve the required increase to Account 633-000 the following budget amendments will be required.

First, a budget amendment to decrease Account 390-089 (Structures and Improvements - Garage Addition) by the amount of \$10,000.00 with a corresponding increase in Unappropriated Balance.

Secondly, an appropriation of funds in the amount of \$10,000.00 to Account 633-000 (Maintenance of Pumping Equipment) with a corresponding decrease in Unappropriated Balance.



RE: Water Division Budget Amendment and Appropriation

The Water Division requests budget amendments to increase account 642-001 (Laboratory Expenses) by \$4,000.00 with the funds to be made available through a decrease of \$2,000.00 in Account 390-089 (Structures and Improvements-Garage Addition) and a decrease of \$2,000.00 in Account 332-089 (Water Treatment Equipment).

The additional funds for laboratory expenses are required due to an increased number of analyses required as a result of the blending program at the Oak St. wells. Funds are available in account 390-089 as it is no longer intended to complete the garage addition and in account 332-089 as no additional expenditures for water treatment equipment are anticipated for the remainder of this fiscal year.

In order to accomplish the nessary increase to account 642-001 the following budget amendments are required:

First, a budget amendment to decrease account 390-089 (Structures and Improvements-Garage Addition) by the amount of \$2,000.00 with a corresponding increase in unappropriated balance.

Second, a budget amendment to decrease account 332-089 (Water Treatment Equipment) by the amount of \$2,000.00 with a corresponding increase in unappropriated balance.

Finally an appropriation of funds in the amount of an increase of \$4,000.00 to account 642-001 (Laboratory Expenses) with a corresponding decrease in unappropriated balance.

RE: Water Division Budget Amendment and Appropriation

The Water Division requests budget amendments to increase Account 614-000 (Maintenance of Wells and Springs) by \$20,000.00 with funds to be made available through a corresponding decrease in the fiscal 86/87 budget account 314-087 (Wells and Springs-Oak St. Site).

The additional funds are required to redevelop wells Nos. 1 and 3 in order to ensure that adequate yield is maintained from these wells. Funds are available in account 314-087 as engineering studies relative to Well #3 have been completed with the recommendation to utilize greensand filtration.

In order to accomplish the required increase to Account 614-000 the following budget amendments are required:

First a budget amendment to the fiscal 86/87 Capital Budget decreasing Account 314-087 (Wells and Springs-Oak Street Site) by the amount of \$20,000.00 with a corresponding increase to prior years' unappropriated balance.

Second, a budget amendment to the fiscal 88/89 budget increasing prior years' retained earnings by the amount of \$20,000.00 and therefore increasing the unappropriated balance correspondingly.

Finally, an appropriation of funds in the amount of an increase of \$20,000.00 to Account 614-000 (Maintenance of Wells and Springs) with a corresponding decrease in unappropriated balance.
