6. Discussion and Possible Action to establish and adopt a formal process for the selection of a vendor for the Wallingford Fireworks Celebration - Councilor Jason Zandri

In view of a light agenda, Town Council Chairman Parisi allowed a full discussion with regard to the Wallingford Fireworks Celebration with statements from Councilors Zandri and Fishbein, who initiated the Fireworks Fund, a 501(C)(3) non-profit, so that the town would not lose this celebration. Some ten thousand people attend this function every July. At the conclusion of the discussion, it was suggested that since only one department can be in charge of selecting a fireworks vendor that the Fireworks Fund might be included in talks with regard to vendors at the beginning of the process. It was recommended that the Mayor, Parks and Recreation Department and the Fireworks Fund all meet to decide on the best way to accomplish vendor selection and to work out the other details involved with the celebration.
