She said that this year town has partnered with the Wallingford Family Y and the Board of Education to expand the 'Fit To Go Program' for tenth through eleventh grade students, an educational component concerning nutrition and proper exercise.

Mayor Dickinson added that this is a program that deals with the health issues of our youth, such as watching weight. This program between the Y and the town is an on-the-ground effort to accomplish something. There are referrals into the program, and the participants enjoy it and seem to benefit.

Mrs. Hazelwood stated that this is a key educational component concerning healthy lifestyle.
