Councilor Marrone spoke about plan design and asked if HSA was proposed. Cindy Lavalette replied that this unit was not interested in plan change. Councilor Fishbein asked if HSA was suggested by her team. Cindy Lavalette responded yes but they were not interested.

Councilor Fishbein asked if there was any reason why they were not interested. Cindy Lavalette replied that she didn't know. Councilor Fishbein questioned if there is a payout cap on sick leave. Cindy Lavalette responded that the cap would be an accumulation of ninety days.

Councilor Fishbein asked about the procedure for a medical exam and if sick leave is being abused. Cindy Lavalette stated that she doesn't have first-hand experience with that. She went on to state that she assumes if they feel an employee is abusing sick leave, they would pay for the exam.

Councilor Fishbein indicated that the language in the contract states people who opt out of the union still pay union dues but that is not how the law is stated.

Councilor Shortell inquired about insurance coverage and asked if we have ever been to arbitration on eliminating the insurance waiver. Dr. Salvatore Menzo replied that he didn't think so. He stated that it is best to try that with a small union, not a large one. Councilor Sullivan stated that arbitration concerns him and we will lose based on our ability to pay. Mayor Dickinson indicated that the Town should watch wages and that wages carry an enormous impact on pensions.

Councilor Fishbein stated that a motion to accept this contract has no effect. Only a motion to reject the contract has an impact.

Mayor Dickinson stated that if the motion to accept is denied, then the contract goes forward but if a motion to reject is approved, then there is no contract in place.
